The Parent Partners Program utilizes the nationally recognized evidence based SafeCare model.

Through fiscal year August 31, 2018, the Parent Partners Program served 126 families which included 302 children. Families enhanced their parent child relationship, reduced challenging behavior. Families improved their essential parenting and child bonding skills 107%. During the Safety module parents learned how to identify reachable and accessible hazards and were able to removed 2,916 hazards from homes.

Parent Aid's Active Parenting classes and Family Enrichment workshops provided 629 parents at 20 different locations important parenting skills and education that will result in children growing up in literacy rich, healthy and positive environments.

All of the programs provided are holistic in nature and work to reduce risk factors for child maltreatment. The programs support parents in developing the skills and knowledge to become successful, this includes:

- Supporting families to identify and connect with other community supports
- Develop and strengthening life skills such as budgeting, family nutrition, home safety, anger management
- Enhance Family Communication
- Increase knowledge of child development
- Improve Family health and nutrition
- Empower families to become self-sufficient and able to cope with and overcome life challenges.
